

1 Judge Walker's order stated that Appellant did not show (A) that bias or prejudice
2 motivated the ruling and (B) failed to set out the facts in detail that would be admissible
3 in evidence and would be sufficient to justify recusal. Appellants reply to Appellees'
4 response filed with the court contains both A and B. Appellant showed that bias
5 motivated the ruling. Appellant set out the facts. Appellant did not defame Appellees.
6 Nothing in the court order which Judge Brigham signed is defamatory as evidenced by
7 the court order and Appellant's responses (Exhibit 3). This shows a clear bias.

8 CONCLUSION

9 Judge William Brigham has demonstrated prejudice against Appellant and has a
10 conflict of interest in Appellant's hearing of indigence. He should be removed from
11 overseeing this hearing.

12 PRAYER

13 WHEREFORE, the Appellant prays that the Judge of this Court immediately
14 request the Presiding Judge of this administrative district to assign another judge to
15 hear this motion, and that upon such hearing Judge William Brigham be disqualified or
16 recuse himself from presiding in this hearing.
